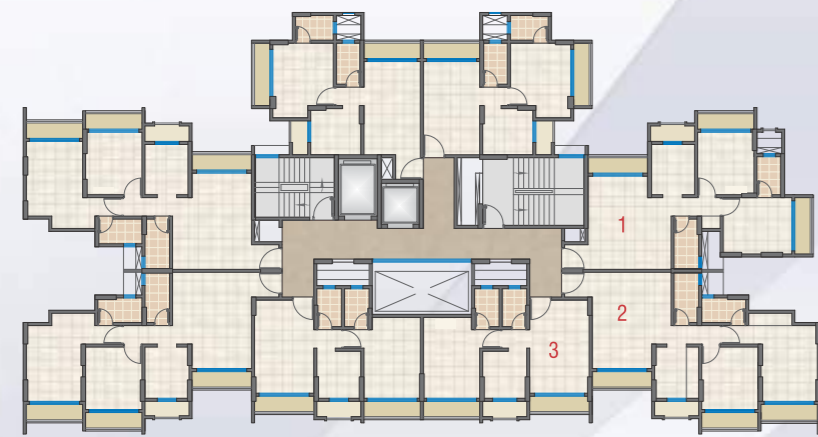
FIRST FLOOR PLAN

Note: Flat no. 4 is refuge on 8th, 12th & 16th floor

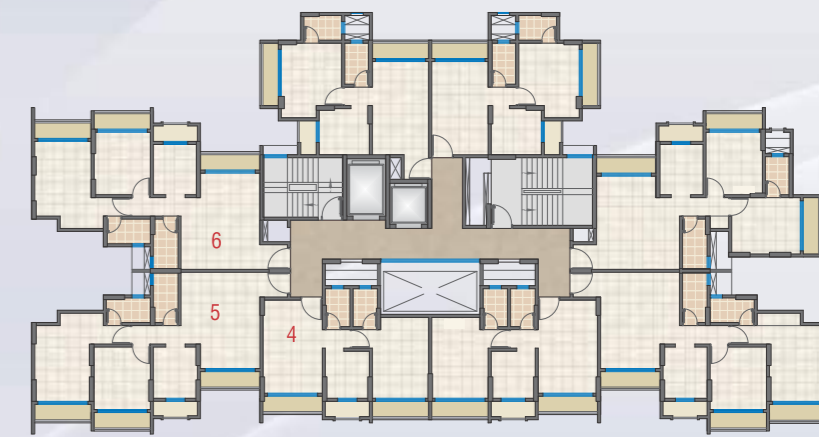

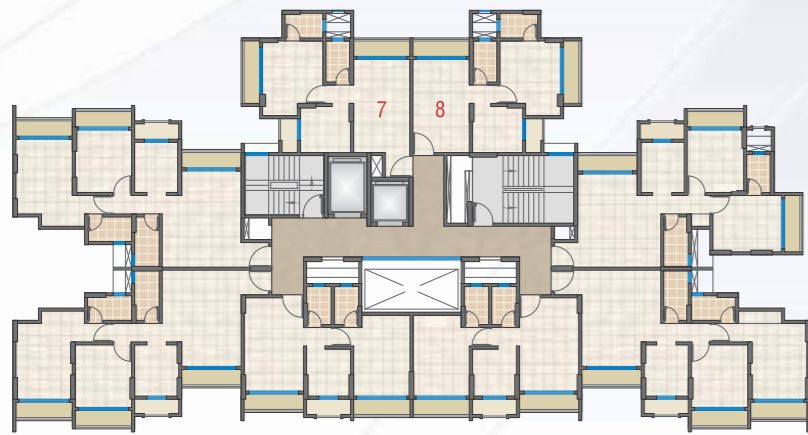

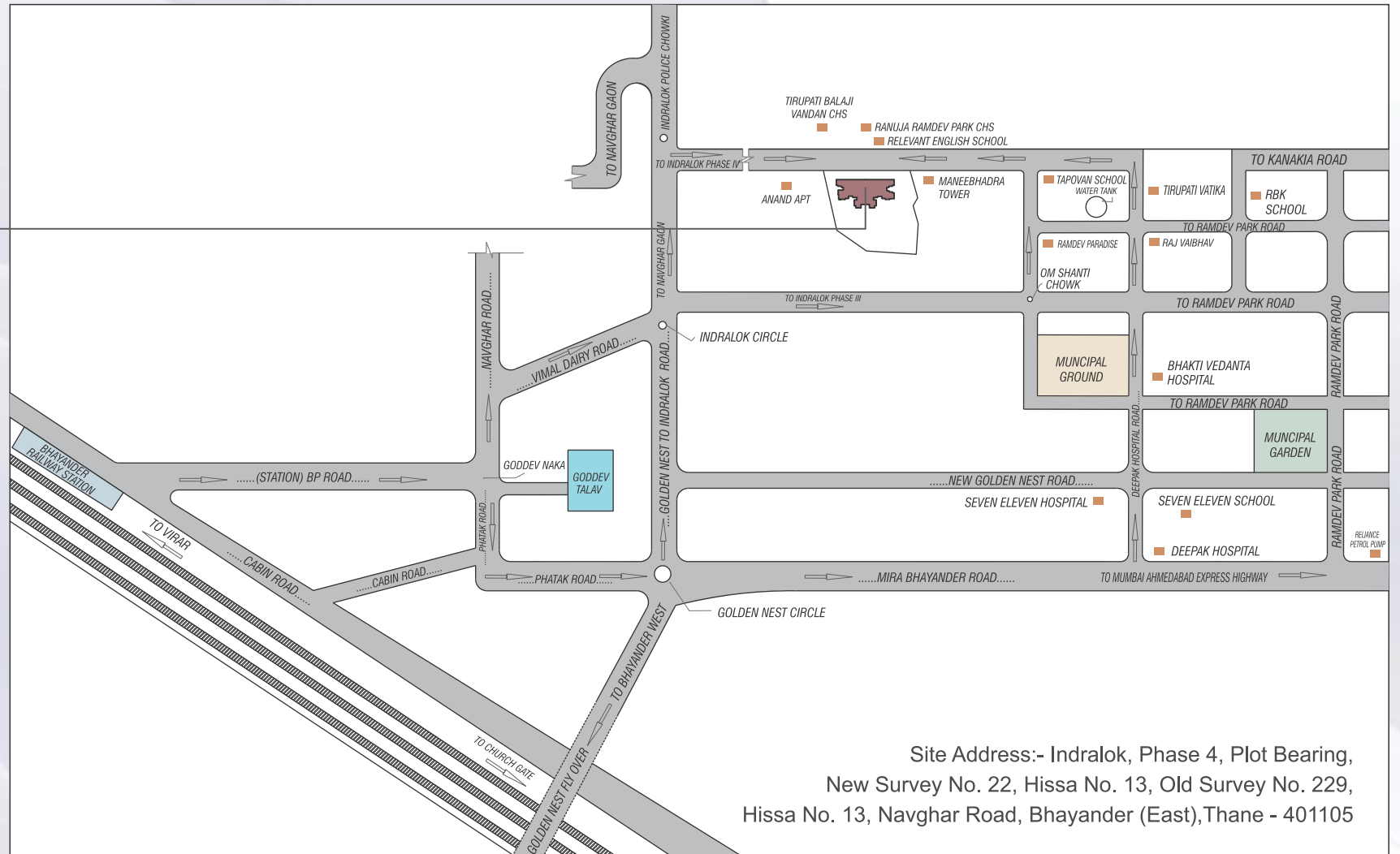
